# Barking Dogs

## A guide for neighbours

**Dogs are an important part of our community and provide many residents with happiness and companionship. However, the City of Norwood Payneham & St Peters occasionally receives complaints regarding nuisance noise from barking dogs. Excessive and prolonged barking, whining, or howling by dogs can become a nuisance to neighbours and other local residents.**

This guide has been created to help residents address concerns about barking dogs, either by communicating directly with the dog owner or by seeking assistance from the Council.

### Why do dogs bark?

Barking is a normal behaviour for dogs and is a form of communication with other dogs and with people. However, from time to time, dogs may bark excessively for a range of reasons such as:

- boredom, loneliness or a lack of entertainment
- discomfort from irritations such as fleas
- unsuitable yards, enclosures or kennel location
- lack of adequate food, water, exercise or training
- protecting territory or feeling threatened
- protecting their owner or family
- strange or new noises or fireworks
- thunderstorms or wailing sirens
- people passing or children playing nearby

### Speak to the dog owner

Residents are encouraged in the first instance to try and resolve the problem with the owner of the dog.

The owner of the dog may not be aware their dogs barking is causing a nuisance, especially if they are not at home during those times.

A calm and respectful neighbourly chat with the owner of the dog can resolve many of these issues. However, for neighbours that do not feel comfortable with the person-to-person approach, a politely worded letter can achieve similar results.

Remember, the more information regarding the nuisance barking the owner has such as times, dates and duration of the barking, the more equipped the owners will be to deal with the issue.

We've prepared a template letter for you to use to communicate nuisance barking to your neighbour, which is included at the back of this guide.

### Council assistance

If you are unable to reach the dog owner or if they have not responded to or have refused to resolve their dog's behaviour, you can contact the Council's Regulatory Services staff on 8366 4555 to discuss your concerns and make a report. On the following pages, we've outlined the actions that will be taken if you make a report about nuisance dog barking.

### Submitting a report

### Information requirements

To lodge a complaint with the Council, you must submit a Barking Dog Complaint form, which is included in this guide, together with an initial nuisance barking diary record. The diary of the dog's barking habits must be kept for a minimum of seven (7) days, noting the date, start time, time ceased and a guestimate of the number of barks per barking occurrence.

For the Council to consider your dog barking as an allegation that requires investigation, you must first show that you have contacted the dog owner and tried to resolve the problem. You can provide this information in the Barking Dog Complaint form.

Estimated Time: about 7 days

**NOTE: If a completed Barking Dog Complaint form and an initial nuisance barking diary record is not provided within fourteen (14) days of the initial report, the Council will not take any further action regarding the barking dog complaint.**

To assist with completing an initial investigation, Council staff may:

- meet with you at your property to assess your concerns and understand the environmental factors which may be contributing to the excessive barking; and/or
- record the dog barking; and/or
- speak to other neighbours to gather additional information

### Contact with the dog owner

If it is determined from an initial investigation that a dog is excessively barking, Council staff will contact the dog owner to remind them of their responsibilities and suggest options that may assist to resolve their dog's excessive barking. A copy of the Council's Barking Dogs: A Guide for Dog Owners will be provided to the dog owner, which includes a list of organisations that offer dog behavioural training.

### Investigations and monitoring

Following initial contact with the dog owner, Council staff will monitor the barking dog's behaviour over four (4) weeks and work with the dog owner to resolve the complaint.

During this period, Council staff will review any further information obtained from their own site observations and or discussions with the other affected neighbours as well as the results of dog barking diaries and data obtained from listening posts set up to monitor excessive dog barking (if applicable).

From time to time, the monitoring stage may be extended to allow for improvements in the dog's barking behaviour, where a dog owner is being cooperative to resolve excessive barking.

Estimated time: 4-6 weeks

**NOTE:** If requested barking dog diaries from neighbours are not provided to the Council or they are incomplete, the Council will not take any further action with the complaint.

### What happens if there is no improvement?

If the dog owner does not satisfactorily address the excessive barking or is uncooperative and there is sufficient evidence of persistent barking nuisance, the Council may issue a Warning Letter, expiation or a Control (Barking Dog) Order.

### Control orders

The Council may issue a Control (Barking Dog) Order if it is satisfied, on the balance of probabilities, that the dog is a nuisance and where the barking noise created by the dog meets the test of "persistently occurs or continues to such a degree or extent that it unreasonably interferes with the peace, comfort or convenience of a person".

A Control (Barking Dog) Order is a legally-enforceable way in which the Council can place restrictions and or specify requirements on a dog owner.

A Control Order generally requires the dog owner to take all reasonable steps to reduce the nuisance barking. This may include undertaking specific training courses or to seek professional assistance to address the dog's barking.

### Documenting evidence

If the Council proceeds with enforcement action by issuing a Control (Barking Dog) Order and/or an expiation, supporting evidence will be required to prove persistent unreasonable barking and its impact on neighbours. This evidence can be in the form of:

- audio or video recordings;
- a diary with date, time and duration of barking recorded;
- an affected party impact statement; or
- a combination of all of the above or other relevant evidence.

Our Regulatory Services staff will talk you through this process and assist you with information on completing diaries.

**NOTE:** The Council will only commence legal action if:

- the owner of the dog is not complying with Council requests; and
- the dog barking continues to be persistent and a nuisance; and
- the complainant is prepared to support their evidence in court.

If the complainant is not prepared to be a witness and appear in court and the council does not have sufficient other evidence to warrant legal action, the Council may terminate its investigation.

### Can councils seize and detain barking dogs?

In situations of excessive barking, the council cannot seize and detain dogs for barking.

Serving and monitoring of a Control (Barking Dog) Order can take between two (2) to three (3) months.

### Further action

The Council may consider taking further action if a Control (Barking Dog) Order has been ineffective and all other efforts have failed to resolve the excessive barking.

If the dog owner fails to meet the requirements of the Control Order:

- an expiation notice may be issued for breaching the control order; and/or
- prosecution may be initiated through the Magistrates' Court, which can lead to strict controls being imposed on the dog.

The process for obtaining a Court ordered direction may take 12–18 months and there is no guarantee that the Council's legal action will be successful.

If Court action is successful, the Council will ask the Magistrate to order that specific controls be placed on the owner of the dog to take certain actions to reduce the occurrence of barking.

### Resolution of complaints

The complaint will be resolved once the Council determines that persistent barking has been addressed and the barking no longer persistently interferes with the peace, comfort or convenience of a person.

Once the barking issue is resolved, the affected parties will be informed in writing and the dog barking complaint will be closed.

If the excessive barking recommences the Council may re-open the investigation, starting at the relevant stage of the investigation process.

### Alternative approaches

#### Civil legal action

*The Dog and Cat Management Act 1995*, provides the legislative framework from which civil action can be taken against a dog owner. Any person can take civil action; however, this course of action can only be initiated by the complainant.

The Council cannot take civil action against a dog owner, on your behalf.

#### Mediation

Mediation can help to resolve conflict and disputes at an early stage, with a view to avoiding the expense and stress of drawn-out legal proceedings.

### 'Dear Dog Owner' note

Print the note on the next page, fill it in and leave it in your neighbour's letterbox.

The note can also be downloaded from the Council's website.

### Privacy

Please be aware that the Council does not disclose your details to the dog owner, however at any stage throughout the process the dog owner does have the right to lodge a Freedom of Information application, which may result in your details being obtained.

## Quick tips to help manage your dog's barking:

- Restrict your dog's vision through fencing and gates.
- Confine your dog to the rear yard, away from passing traffic.
- Ensure your dog gets plenty of exercise and mental stimulation.
- Provide adequate shelter, food, and water.
- Use toys and puzzles to keep your dog occupied.
- Create a calm environment with reduced noise levels.
- Maintain a consistent daily routine for your dog.
- Seek advice from a vet or animal behaviourist


